Dear Parent/Guardian and Campers,

Welcome to Paddleboarding and/or Surf camp for Summer 2024. Thank you for choosing to spend part of your summer vacation with us! The purpose of this handbook is to provide needed information, to answer some questions you may have and to ensure all participants have an enjoyable camp experience.

**Registration:** Camps fill early! A deposit of \$50.00 will guarantee that we hold a place for you for the week you desire to attend. Deposits can be made in the form of check, credit card or cash. Please indicate the week you desire to attend and a second choice, if you have one.

**Payment:** Payment in full is due two weeks (14 days) prior to the first day of camp. We accept payment in the form of check, credit card or cash. You can also remit payment in full online at our website at: [www.eastcoastpaddleboarding.com](http://www.eastcoastpaddleboarding.com) We are prohibited from accepting any payment, in any form, at the beach. All registration documents must be completed prior to the first day of camp. A student will not be allowed to participate in any camp activity without all paperwork properly completely and payment made in full.

**Refund Policy:** Refunds will be in full if cancellation is received in writing (via e-mail or mail) within thirty (30) days prior to the start camp. Refunds will not be given for missing any day of camp or for weather cancellations.

**Cancellation:** East Coast Paddleboarding may cancel or postpone a camp or activity because of insufficient enrollment, inclement weather or other unforeseen circumstances. If the need arises to cancel an entire week, we will make every attempt to accommodate your child/children during another week.

**Camp Hours:** Monday through Friday from 8:30 am. until 11:30 am.

**Drop Off/Pick Up Procedures:** Students need to be signed in by an adult on the "authorized pick up list" and should be picked up by the same adult each day. Otherwise, only adults listed on the "authorized pick up list" section of the Camp Registration Form with Photo ID will be permitted to pick up your student. Please be sure to include everyone that you want or need to pick-up your student on the Camp Registration Form. If at all possible, let the instructor know in the morning if someone else on your list will pick your child up that day.

**Emergency Contacts:** Emergency contact information must be completed as part of your student's registration packet.

**Personal Items:** Students should not bring toys, electronics or other personal items and/or items of value to camp. There is no secure location on the beach to leave valuables. If your child does bring a cell phone, we ask that the device be used only in emergency situations and that the phone remain in the "off" position during all camp activities. No text messaging is allowed during camp activities!

**Attire:** Swimsuit/Swimshirt/Trunks  
Rash guard  
Sunglasses (with "Croakies")  
Hat/visor  
Sunscreen

**What to bring:** Sunscreen  
Towel  
Dry clothing, if desired  
Snacks  
Water/beverages

- \*Children must bring their own snacks & beverages (no soda) daily.
- \*It is helpful to pack snacks & beverages in an insulated cooler or lunch box.
- \*We will have no way to cool or heat snacks at the beach.
- \*Healthy, high energy snacks, nutritious snacks are encouraged.
- \*We will take many water breaks! Please be sure to send your child with plenty of water and/or beverages.
- \*Please label all items with the child's name or initials, as many look alike.

**Safety:** Safety is of utmost concern. Your child must be able and willing to follow all directions and respond accordingly.

**Conduct:** All campers are expected to respect, listen, and follow staff instructions. However, if a camper is disrespectful to other participants, to staff or property, or does not follow directions and rules, East Coast Paddleboarding reserves the right to remove the participant from the group, temporarily or permanently. Any participant dismissed from camp will not receive a refund.

While unacceptable conduct is not anticipated, East Coast Paddleboarding is prepared to deal with situations involving inappropriate behavior. East Coast Paddleboarding reserves the right to dismiss any participant for inappropriate behavior. We have a "two strikes" policy regarding conduct. Students will be given one warning before a parent/guardian is notified and the participant dismissed.

In addition, there are certain situations for which a "**No Tolerance Policy**" exists. Any act that could be considered dangerous to the participants and/or staff is grounds for immediate dismissal. Any act that threatens the well being of another, participant, staff or public, will result in immediate dismissal from the camp.

Some examples of inappropriate behavior which falls under the "No Tolerance Policy" may be, but are not limited to:

- \*cursing, or use of profanity
- \*bullying of any sort, or in any degree
- \*fighting or roughhousing
- \*misuse or damage of paddleboarding gear
- \*stealing or touching personal property belonging to another person, unless permission has been given
- \*leaving the group without permission of instructor
- \*inappropriate touching or violation of another participant's or staff's personal space
- \*leaving without being properly signed out
- \*use or possession of drugs, alcohol, tobacco, weapons, firearms or explosives
